# Terms of Service

Read our terms below to learn more about your rights and responsibilities as a thirdSelf member (“user”).

\* **Note: thirdSelf is not affiliated with Facebook, Instagram, Medium or LinkedIn nor any other external product not owned by thirdSelf.** Any mention of such products on our website or social profiles exist merely to point out that a user’s content, which may exist on such entities, may be migrated directly or indirectly into a thirdSelf profile (as long as the user is the author of such content).

This Terms of Service (the “Terms”) describes the rights and responsibilities that apply to your use of thirdSelf’s websites, services, and mobile app (collectively, the “Service”), each owned and operated by thirdSelf Co. (“thirdSelf”, “we”, “our” or “us”).

Please read the Terms carefully before using the Service. If you don’t agree to the Terms, as well as thirdSelf’s Privacy Policy (the “Privacy Policy”) and thirdSelf’s Community Guidelines (the “Community Guidelines”), you may not use the Service. If you are entering into the Terms on behalf of a company or other legal entity, you represent that you have the authority to bind such entity to the Terms. If you do not have such authority, you must not accept the Terms or use the Service on behalf of such entity. The Service is only available to you if you have entered the age of majority in your jurisdiction of residence and are fully able and competent to enter into, abide by and comply with the Terms.

**1. Your thirdSelf Account.** If you create an account on the Service (your “Account”), you are responsible for maintaining the security of your Account and its Content (as defined below), and you are fully responsible for all activities that occur under your Account and any other actions taken on the Service.

You must not describe or assign Content to your Account in a misleading or unlawful manner, including in a manner intended to trade on the name or reputation of others, and thirdSelf may change or remove any description or keyword that it considers inappropriate or unlawful, or otherwise likely to cause thirdSelf liability. For paid Accounts (each, a “Paid Account” or “Premium Account”), thirdSelf deems the person under whose name appears on the credit or charge card or other payment method that pays the charges for the Service to be the owner of the Paid Account. If a corporate or other organization’s name appears on the credit or charge card or other payment method, that corporation or organization is deemed to be the owner. If any dispute arises as to who owns or controls a Paid Account, your most recently provided payment method will continue to be charged and you will be responsible to pay for the Service until ThirdSelf receives written confirmation from the Paid Account email address confirming a change in ownership and control of the Paid Account.

**2. Fees and Renewals.** Pricing for Paid Accounts will be provided at the time of purchase. Unless otherwise set out at the time of purchase or as agreed to by thirdSelf, fees for a Paid Account will be billed in advance for each year and are non-refundable. There will be no refunds or credits for partial months of service or for periods in which your Paid Account remains open but you do not use the Service.

Subject to your payment of applicable fees for a Paid Account, we will provide the Service to you for the period of time that you have paid for such Service (the "Subscription Period"). At the end of the Subscription Period, your Paid Account subscription will automatically renew for an additional Subscription Period until it is expressly cancelled by you as described in the "Termination" section below.

If you purchase any fee-based Service, you agree that our third-party payment gateways, such as Stripe and Paypal, may store your credit or charge card or other payment information. You expressly agree that we are authorized to charge you (i) a fee for any applicable Service for which you have subscribed, billed on a basis of the Subscription Period, (ii) any other fees for the Service you may purchase, (iii) any charges for use of the Service in excess of the usage or other limits placed on your use of the Service (and you hereby consent to such charges and agree we are not required to notify you of any such charge in advance) and (iv) any applicable taxes in connection with your use of the Service to the credit or charge card you provide and to reimburse us for all collection costs and interest for any overdue amounts. If the credit or charge card you provide expires and you do not provide new credit or charge card information or cancel your Account, you authorize us to continue billing you and you agree to remain responsible for any uncollected fees.

**3. Your Responsibilities.** If you operate an Account, comment on a screenshot, post material to the Service, post links on the Service, or otherwise make (or allow any third party to make) material available by means of the Service (any such material, "Content"), you are entirely responsible for the content of, and any harm resulting from, that Content. - your Account is not named in a manner that misleads your readers into thinking that you are another person or company. For example, your Account's URL or name is not the name of a person other than yourself or company other than your own; and
- you have, in the case of Content that includes computer code, accurately categorized and/or described the type, nature, uses and effects of the materials, whether requested to do so by thirdSelf or otherwise.

By uploading Content or otherwise providing Content to thirdSelf, you grant thirdSelf the right to use (including the right to host, index, cache and format) and display your Content in connection with providing the Service as well as otherwise on the Site and our marketing communications with you and other users and prospective users of the Service, including without limitation on our emails, marketing channels and other promotional materials (subject to the requirements set out in the Privacy Policy). This means thirdSelf reserves the right to alter or modify the rules of the “freelancer economy” or “freelancer ecosystem” at any time. thirdSelf’s issuance of 3RS Tokens will follow the Terms and Conditions which are separate from this document. thirdSelf reserves the right to eliminate the 3S Credit incentive program and cancel the launch or issuance of 3RS Tokens to any eligible member as well as reserve the right to cancel the freelancer economy roadmap at any time.

**5. **8. Termination.** ThirdSelf may terminate your access to all or any part of the Service at any time, with or without cause, with or without notice, effective immediately. If you wish to terminate the Terms or your Account (if you have one), you may simply discontinue using the Service. All provisions of the Terms which by their nature should survive termination shall survive termination, including, without limitation, ownership provisions, warranty disclaimers, indemnity and limitations of liability.

**9. Disclaimer of Warranties.** Your use of the Service and all Content forming part of or related to the Service, including any Content you upload or submit and any third party software and Content, are at your sole responsibility and risk. **10. Limitation of Liability.** You agree that, under no legal theory, including, but not limited to negligence, breach of warranty or condition, breach of contract or tort, will thirdSelf or its owners, officers, directors, affiliates, contractors, employees or agents, be liable to you or any third party acting on your behalf for any indirect, incidental, special, consequential, punitive, or exemplary damages or damages for loss of profits, goodwill, use, data, or other intangible losses or the cost of any substitute equipment, facilities or services (even if thirdSelf has been advised of the possibility of such damages), arising from or relating to the Terms or your use of or your inability to use the Service, or for any damages arising from or related to the Terms. thirdSelf's total aggregate liability from any and all claims under the Terms is limited to the total amounts you paid to thirdSelf in the one (1) year immediately preceding the occurrence of loss or damage. To the extent any province, state or jurisdiction does not allow the exclusion or the limitation of liability for consequential or incidental damages, thirdSelf's liability in such province, state or jurisdiction will be limited to the furthest extent permitted by law. Notwithstanding the foregoing or anything else herein to the contrary, thirdSelf will not be liable to you or any third party acting on your behalf in any way with respect to a trial program or your provision of an individual's personal information to thirdSelf or through the Service. You agree that you will not bring a claim under or related to the Terms more than one (1) year from when your claim first arose.

**11. General Representation and Warranty.** You represent and warrant that (i) your use of the Service will be in strict accordance with the Terms, the Privacy Policy, the Community Guidelines and all applicable laws and regulations (including without limitation any local laws or regulations in your country, state, city, or other governmental area, regarding online conduct and acceptable content, and including all applicable laws regarding the transmission of technical data exported from the country in which you reside) and (ii) your use of the Service will not infringe or misappropriate the intellectual property rights of any third party.

**12. Indemnification.** You agree to indemnify, defend, and hold harmless thirdSelf, and its subsidiaries, affiliates, co-branders, all third-party advertisers, technology providers, service providers or other partners, and each of their respective officers, directors, agents, shareholders, employees and representatives (together, the "Indemnified Parties"), from and against any third party claim, demand, loss, damage, cost, or liability (including, reasonable attorneys' fees) (collectively and individually, "Claims") incurred by or made against the Indemnified Parties in connection with any Claims arising out of or relating to the Terms, the Service, including but without limitation in relation to: (a) your use, non-use or misuse of, or connection to the Service and any Content; (b) your violation or alleged violation of the Terms; and (c) your violation

of any rights, including intellectual property rights, of a third party and otherwise as set out herein. ThirdSelf reserves the right, at your expense, to assume the exclusive defense and control of any matter for which you are required to indemnify thirdSelf and you agree to cooperate with ThirdSelf's defense of these Claims. You agree not to settle any matter without the prior written consent of thirdSelf. thirdSelf will use reasonable efforts to notify you of any such Claims upon becoming aware of it.

**13. Miscellaneous.** If there is any dispute between you and thirdSelf about or involving the Terms, the Service, you hereby agree that the dispute will be governed by and construed in accordance with the laws of New York State in the United States.

Except for any claim involving the ownership of intellectual property, all disputes arising out of or in connection with the Terms will be referred to and finally resolved by arbitration under the rules of the United States Legal System where thirdSelf is headquartered, primarily in New York New York. The language of the arbitration will be English.

If any portion of the Terms is deemed unlawful, void or unenforceable by any arbitrator or court of competent jurisdiction, the Terms as a whole will not be deemed unlawful, void or unenforceable, but only that portion of the Terms that is unlawful, void or unenforceable will be stricken from the Terms.

You agree that the Terms are specifically enforceable by thirdSelf through injunctive relief and other equitable remedies without proof of monetary damages. You agree that if thirdSelf does not exercise or enforce any legal right or remedy which is contained in the Terms (or which thirdSelf has the benefit of under any applicable law), this will not be taken to be a formal waiver of thirdSelf's rights and that those rights or remedies will still be available to thirdSelf.

The Terms are the entire agreement between us related to the subject matter in the Terms. The Terms replace and supersede any other prior or contemporaneous agreement, representation or discussion, oral or written, and may not be changed except in writing signed by us, regardless of whether or not the parties act under an unsigned “electronic” agreement or rely on such an unsigned agreement.
